coral atolls and reef islands of the Outer Islands. The granitic islands of the Seychelles archipelago cluster around the main island of Mahé, home to the international airport and the capital, Victoria, and its satellites Praslin and La Digue. Together, these Inner Islands form the cultural and economic hub of the nation and contain the majority of Seychelles' tourism facilities as well as its most stunning beaches.

Seychelles' location outside the cyclone belt, in a time zone whose working hours overlap with those of major financial centres, its excellent sea and air connections with Europe, USA, Asia and Africa make it an excellent place to conduct business.

An efficient telecommunications system together with other advantages such as the extensive facilities available at its harbour, Port Victoria, and a well-developed infrastructure with attractive investment incentives, offer the ideal business environment to investors. ## ABOUT SEYCHELLES COMPANY FORMATION OUR SERVICES:

Guided by IBC, Seychelles Companies have the following registration requirements:

- Directors which must always be one in case of Seychelles, since the business laws only require one director who may come from any nationality or country.
- Seychelles Companies require only one director and one shareholder, roles which can be played by one person.
- The nominated shareholders and managers are accepted to help provide the services needed for offshore activities.
- The share capital is regulated by the stakeholders and there is no specificity in the amount of shares to be paid by the members. The shares can

be in any form (in currency or any trade valuable) as long as it's acceptable by the members.

- There is no on sales tax registration fee as the Seychelles foreign companies are left tax free.
- The register of all directors and their share values must be kept and edited regularly. These registers can be kept anywhere, a place that deems best by the members of the board.
- The privacy of the registered director or a registered shareholder is maintained through the nominee who provides the services on their behalf.
- The registration process of a Seychelles Company requires the specified corporation to have an office in Seychelles registered in its name. Of importance to note is that, Seychelles Companies must have their names ending with phrases or an abbreviation of the name.
